intended to stimulate discussion and encourage the collective exploration of solutions to the many challenges faced by our military community during their educational pursuits. We will cover topics in several areas including the quality of distance learning, innovative technologies, transition, retention/completion measures and best practices, Post 9/11 GI Bill amendments, State Authorization Regulation Chapter 34, § 600.9(c), reports from the Service Chiefs, Servicemembers Opportunity Colleges (SOC) Burning Issues, and much more.

We are fortunate to have two very dynamic speakers confirmed on the agenda already.

Sir John Daniel, President of Commonwealth of Learning (www.col.org) will join us on Tuesday, February 14, 2012 to open our symposium. Sir John became President of Commonwealth of Learning in 2004 after gaining wide international experience in universities and the United Nations System. Following the completion of his university education in Metallurgy at Oxford and Paris, he demonstrated his commitment to lifelong learning by studying part-time for 25 years to complete a Master's degree in Educational Technology at Concordia University. He held senior positions at the Télé-université, Athabasca University, Concordia University, Laurentian University, the UK Open University and the United Nations Educational, Scientific and Cultural Organization (UNESCO). Sir John was knighted by Queen Elizabeth for services to higher education in 1994 and holds 30 honorary doctorates from universities in 17 countries.

Among Sir John's 300 publications are his books *Mega-Universities and Knowledge Media: Technology Strategies for Higher Education* (Kogan Page, 1996), and *Mega-Schools, Technology and Teachers: Achieving Education for All* (Routledge, 2010).

Dan Clark will join us on Thursday afternoon, February 16, 2012 to close the symposium. Many of you know Dan as the primary contributing author to the *Chicken Soup for the Soul* series and author of *Chicken Soup for the College Soul*. He is also author of the highly acclaimed business leadership book, *Forgotten Fundamentals*, and the inspirational *Puppies for Sale* which was made into a film at Paramount Studios starring Jack Lemmon.

Dan is a graduate of the Executive Program at both Air University in Montgomery, Alabama, and the Army War College in Carlisle, PA. His long list of appearances in the military environment includes the Air Force Four Star General's Corona Leadership Conference, Air Force General's Commanders Conferences throughout the world, Army General Walter Sharp's Conference in Korea, the Air Force Academy's Character and Leadership Development Symposium, the National Conference on Ethics at West Point, Tech training schools at Keesler and Sheppard AFB, Ft. Hood, Ft. Bragg and Ft. Jackson, as well as officer schools for Majors, Colonels and Generals. He has spoken to over 4,000 audiences and more than 3 ½ million people in all 50 states and 35 countries, and to our combat troops in Iraq and Afghanistan. Dan currently serves on the Chief of Staff of the Air Force National Civil Leaders Board.

Call for Concurrent Session Proposals

Help us spread the word about how academe, corporations and federal organizations are paving the way for our total military community through innovative educational programs and service partnerships. Share your "Best Practices" that will engage conversation and promote community interests for all attendees. The theme for the 2012 CCME Annual Symposium is "Salute to Possibilities: Paving the Way for Our Military Community". Proposals can be submitted on line at CCME Concurrent Session Proposals from June 15 to September 16, 2011.

The demands placed today upon our military members and their families continue. Pentagon data shows that over 1.8 million troops have been deployed since September 11, 2001. Over 300,000 veterans are coping with mental health issues. Over 100,000 Reserve and Guard members remain activated. A recent RAND Corporation study shows that spouses and family members of deployed service members are suffering from higher levels of emotional difficulty and anxiety symptoms compared to other spouses and children their age. According to Department of Veterans Affairs Secretary Eric Shinseki the economic downturn and the trauma of the wars in Iraq and Afghanistan have placed a severe burden on our military and veterans. According to Shinseki only eight million of the approximately 23 million veterans in the United States are even registered with VA. He described a backlog of Veterans Affairs cases or disability claims that has soared to over 700,000 in 2010 up from 450,000 the year before. A large number of the new cases involve younger veterans of the wars in Iraq and Afghanistan suffering from post-traumatic stress disorder (PTSD). Recently we have all been hit with the news that the Department Defense must cut spending over 78 billion during the next five years and those education programs that support the military community are at risk. Finally the recent focus by Congress, the Department of Education and the Defense Department has raised the awareness that DOD should increase its oversight of institutions receiving Tuition Assistance Program funds to prevent potential waste and abuse. In recent months, some members of Congress have spotlighted allegations that institutions have abused the TA programs. Institutions are anxiously waiting a number of Department of Education changes that are sure to be difficult to implement. We want to hear your perspectives on "Salute to Possibilities: Paving the Way for Our Military Community" and ways we can better serve our military community. We encourage you to actively participate in the 2012 Symposium by submitting a proposal for a concurrent session. Some suggestions for this year's concurrent sessions are:

- 1. Programs, partnerships and best practices to help veterans achieve their education goals and find meaningful careers.
- 2. Best practices and innovations in educating and supporting the military community.
- 3. Achieving and measuring quality, equity and efficiency in higher education.
- 4. Understanding and addressing the impact of the recent changes to the Department of Education programs and the VA Post 9/11 GI Bill.
- 5. Introduction of new tools, technologies and programs to enhance distance education.
- 6. Using social media to support the education of the military community.
- 7. Innovative outreach and marketing programs that support the military community.

We will provide the final tracks for the concurrent sessions when we open the Concurrent Session web page. The deadline for proposal submissions is **Friday**, **September 16**, **2011**. All presenters are expected to pay the CCME conference registration fee if attending the entire conference.

- Intent of the proposal is to engage the audience


